



STATEMENT OF CONDITIONS AND AGREEMENT WITH "MR. TRUCK, INC."

I agree to pay a deposit of \$1500 for services before commencement of services in this case. In the event that charges for services are less than \$1500, I understand the unused portion will be refunded to me.

I understand that under certain circumstances, advance payments may be needed to maintain a \$0 balance. Should commercial air travel be necessary, the cost will be billed against the retainer.

Payment for services is expected within 21 calendar days after "Mr. Truck" sends a statement of my account; accounts unpaid 21 calendar days after sending the initial statement are subject to the addition of a \$50 late fee (per month); accounts unpaid may be subject to cessation of services and submission to the Courts.

I agree to the following FEE SCHEDULE:

\$105 / hr. For support staff services as needed;
\$175 / hr. Photo, video, computer graphics and animations;
\$250 / hr. Consultation, records review, fieldwork, travel time, and second person as needed;
\$350 / hr. Deposition, arbitration and trial time;
\$0.80 / mile; all other expenses as billed to "Mr. Truck"

- It is understood that this agreement does not secure Mr. Truck's agreement to be an expert witness in my case. It does secure an agreement to review the records provided and offer consultation. I understand that upon completion of analysis, Mr. Truck will advise me of his conclusions, and at that time, he will agree/decline to function as an expert witness in this case.
- All reasonable charges incurred in the review of the documents provided and/or in the reimbursement of separate legal counsel will be paid in a timely manner independent of any subsequent agreement (or declination) to function as an expert witness in this case.
- Mr. Truck will proceed with all studies and exhibit development unless I expressly request in advance that my written approval be obtained first.
- Cases that need opinions, written reports, and/or testimony within 20 working days of receipt of deposit, signed fee agreement, and all necessary documents, require a \$1500 rush fee, in addition to the retainer, before commencement of work.
- I agree to the above Statement of Conditions and Agreement. Should I question the billing services, I will advise Mr. Truck's office within 10 days of receiving the statement of accounts.
